## MILL VILLAGE SEWER UPGRADE

The majority of the citizens do not know the inner workings of the collection (sewer) system. The only thing they care about is if the water is running and commodes are flushing. The Town of Red Springs has contracted with ELJ general contractor. In the Mill Village area of Red Springs, we are upgrading the sewer system. This consists of a new lift station, new manholes, and sewer mains. In 2014, Red Springs upgraded the hydrants and water mains in this area. The Town of Red Springs chose this area for the upgrade because the infrastructure was deteriorating. The majority of all the lines in this area were installed in the 1940's. The majority of the sewer mains are being replaced with PVC. For the sewer mains that are no in that bad of shape, those lines will be slipped lined with Cured in Place Pipe (CIPP). After the contractor has completed the upgrade, the streets that were damaged will be repaved. We are sorry for any inconvenience this upgrade has caused to the citizens. The Town of Red Springs has the citizen's best interest in mind. We are striving to enhance the lives of our Residents. In doing so, it can cause delays and congestion while traveling in this area. ### ALLOWAY CEMETERY COLUMBARIUM



As times change more people are being cremated. This process is cheaper than the traditional type of funeral, which consists of using a casket and vault. The Town of Red Springs has installed columbarium, which holds 312 niches. for those who wish to be cremated. Each niche can hold two standard urns. When you purchase a niche, it comes with a granite face plate. You can then have it engraved with your loved ones

information. The columbarium was a vision of the previous Public Works Director, George Hall. Mr. Hall and the previous Town Manager, James Bennett, did the majority of the foot work on this project. Red Springs has been working on the new section of Alloway cemetery for over seven years. In December 2017, the former Town Manager, James Bennett contracted with Green Scape to do the landscaping around the columbarium. The Town of Red Springs still has some work to be done in the new section of Alloway Cemetery. The next project is to install and repair the entrance roads. If you are interested in purchasing a niche the cost is \$500.00 ea. for town citizens.




